

ADOPTION/RELEASE AGREEMENT

ADOPTION TERMS

This Adoption Agreement (the "Agreement") is made on this ____ day of ____ between Southern California Pit Bull Rescue ("SCPBR"), a California Non-Profit Organization, and _____ as the adopting owner(s) ("Adopter") with SCPBR and Adopter together known as the Parties.

1. **Identification:** Adopter agrees to provide a safe collar with I.D. tags to be worn at all times. Your dog has been microchipped and registered with SCPBR. The chip details will be included in the adoption packet. Please add your details to the registration. SCPBR **must** remain on the registration as well.
2. **Living Conditions:** The Adopter agrees that the dog will reside in the Adopter's home and live as a family member and companion only. The dog is never to be left out in the hot sun or outside in freezing temperatures. The dog is never to be left tethered to a fence/pole, or any other object. Fresh water is always to be accessible.
3. **Fence Policy:** SCPBR has a policy with regard to the adoption of any dog. Adopter agrees that should this adoption be completed for a dog and that they will maintain a minimum 6-foot fence completely surrounding the home's yard. This fence is to be made of solid construction. Invisible or electronic fences will not be accepted. The gates should be secured at all times.
4. **Health Program:** The dog will be placed on a vaccination program established by the veterinarian of the Adopter's choice. The Adopter will provide adequate food, fresh water, shelter, protection, and any medical care needed by the dog.
5. **Spay/Neuter:** If the dog has not been spayed/neutered at the time of this adoption, Adopter agrees to have the surgery done by _____. This surgery is to be completed by a veterinarian authorized by SCPBR in order for SCPBR to assist in the cost of the surgery. In the event the dog is not altered by the date agreed upon, then ownership of the dog shall revert to SCPBR upon demand.
6. **Euthanasia:** The Adopter agrees that the dog shall not be euthanized except in the case of the dog's terminal illness, injury or old age accompanied by pain and suffering. In this event, the euthanasia must be performed by a licensed veterinarian.
7. **Training Policy:** It is highly suggested you and your family complete a basic training course with your new dog.
8. **No Refunds:** There are no refunds. The Adopter is adopting and their donation includes but is not limited to the dog's basic veterinary care, heartworm test, spay/neuter surgery and microchipping.
9. **No Warranty:** SCPBR makes no warranty as to the temperament or physical condition of the dog. The dog is being adopted as is.
10. **Release & Indemnification/No Liability:** Adopter hereby releases SCPBR from any and all liability for personal injury, property damage, legal fees, veterinary costs, or any other expense or liability incurred by Adopter as a result of this adoption. Adopter agrees to indemnify SCPBR from any and all such claims and to pay, without limitation, any costs related to such injury, damage, or liability, including, in the case of litigation, any attorney fees incurred by JGRI in its defense.

11. **Breach of Agreement/Liquidated Damages:** In the event that Adopter does not comply with the terms of the Agreement, or the dog is abused or neglected, SCPBR holds the right to recover the dog from the Adopter upon demand, and the dog will be surrendered to SCPBR immediately.
12. **Entire Agreement/Modification/Binding Effect:** This Agreement is the entire Agreement between the Parties and supersedes any prior understandings between the Parties with respect to the subject matter of this Agreement. No modification of the Agreement will be valid unless in writing and duly signed by both Parties. This Agreement is binding upon the Adopter and their heirs, assigns, successors, personal representatives and executors.
13. **Good Faith agreement:** By adopting said dog, adopter agrees to care for the dog for its lifetime
14. **Right to Reclaim:** Adopter understands and agrees that SCPBR reserves the right to reclaim the dog if any of the above conditions are not met to the satisfaction of SCPBR Adopters further understand

15. **Parties below, the Parties acknowledge that we have carefully read the entire agreement and understand and agree to the release, indemnification and other terms provided herein.**
